

# Notification to the CoC of Renewal and New Project Selection and Ranking (FY23 HUD CoC Program NOFO Competition)

Dear NE-501 (MACCH) HUD Continuum of Care grantees, members and stakeholders:

### Below is an important notice regarding the FY 2023 HUD CoC Program NOFO Competition.

This message summarizes the list and status of all projects submitted to the NE-501 (MACCH) CoC as part of the FY2023 HUD CoC Program NOFO competition. This includes: renewal projects that have been for funding accepted at their full renewal amount; new projects accepted for funding at or above the requested amount; new projects accepted for funding at a budget less than the requested amount; and new projects that were not selected for funding. This announcement, including the project ranking, scores, and funding amounts, is posted to MACCH's website, in addition to the Board-approved ranking and tiering document.

Please note that organizations that submitted a new project application that was not selected, have been informed of the CoC's decision prior to the distribution of this message.

## **RENEWAL PROJECTS**

The following renewal projects have been accepted by the CoC and will be ranked on the Renewal Priority Listing submitted to HUD. Each of these projects will be submitted at the full Annual Renewal Amount, as indicated on the CoC's 2023 Grant Inventory Worksheet:

## **CoC PLANNING PROJECTS**

### **NEW PROJECTS**

The CoC received **4** new project applications totaling **\$642,760** in funding, all for consideration under the CoC Bonus. The CoC had a total of **\$371,340** in funding available to award from the CoC Bonus, and **\$530,486** in funding to award from the DV Bonus. The CoC did not receive any applications for the DV Bonus.
