



Metro Area Continuum of Care for the Homeless

Dear NE-501 (MACCH) Continuum of Care grantees, members and stakeholders:

**The below is an important notice regarding HUD's Special NOFO to Address Unsheltered and Rural Homelessness (Special NOFO Unsheltered Set Aside).**

On June 22, 2022, HUD published the Continuum of Care Supplemental to Address Unsheltered and Rural Homelessness (also known as the "Special NOFO"). The NE-501 (MACCH) CoC is solely eligible for the Unsheltered Set Aside within this Special NOFO. This Special NOFO requires CoC's to conduct a local competition to select new projects for this opportunity. This email summarizes the list of projects that have been accepted by the CoC and will be included in the NE-501 (MACCH) CoC 2022 Project Priority List for funding under the Special NOFO Unsheltered Set Aside.

**NEW PROJECTS**

The CoC received **6** new project applications totaling **\$6,551,531.54** in funding. **The CoC had a total of \$5,166,627.00 in funding to award under the Special NOFO Unsheltered Set Aside.**

The following new projects have been accepted for inclusion on the New Project Priority List for the Special NOFO Unsheltered Set Aside and will be ranked on the CoC's New Project Priority List. Note that the budgets below represent *3-year budgets*, as HUD will award selected projects with an initial 3-year grant term.

- **Together; Horizons PSH 2 Program; \$734,352; Score: 86.30%; Rank: #1**
- **Institute for Community Alliances; Omaha Metro Area Continuum HMIS – Unsheltered Set Aside FY22; \$52,704; Score: 84.62%; Rank: #2**
- **Heartland Family Service; Street Outreach; \$1,688,397; Score: 81.43%; Rank: #3**
- **Heartland Family Service; Encompass Housing; \$2,027,534; Score: 77.04%; Rank #4**
- **New Visions Homeless Services; Street Outreach; \$467,508; Score: 70.48%; Rank #5**
- **Together; Homeless Street Outreach; \$196,132; Score: 34.29%; Rank: #6**

The following organizations submitted preliminary applications to the CoC, but were not selected for funding:

**The CoC did not reject any preliminary applications submitted under the 2022 Special NOFO.**
